



"The best photo from Tour de France 2020" contest rules

Article 1

The organizer of the "The best photo from Tour de France 2020" prize contest is PROFIDTP, d. o. o., Gradišče VI 4, 1291 Škofljica, Slovenia (hereinafter referred to as the organizer).

Article 2

The prize contest will take place on the Tadej Pogačar website (<https://tadej-pogacar.com>). Everyone who accepts and agrees to the rules of the prize contest has the right to participate in it under the same conditions. The prize contest runs from November 16th 2020 to November 20th 2020.

Article 3

From all correctly submitted votes for the prize contest "The best photo from Tour de France 2020", the winners will be selected by a lucky draw after the completion of the prize contest. The lucky prize draw will take place on November 23rd 2020, at 10.00 am at the PROFIDTP premises. The prizes will be awarded to the lucky winners who voted for the winning photo and submitted all the required information via the online form at <https://tadej-pogacar.com/>.

The prize pool consists of the following:

- 1st place prize: Poster with the motif of the winning photo, measuring 90 x 64 cm.
- 2nd place prize: A pair of Tadej Pogačar cycling socks
- 3rd place prize: Water bottle Tadej Pogačar

Article 4

The winners will be informed about the prize via the submitted e-mail. To receive the prize, the winner must provide information for the delivery of the prize. The prize will then be sent by postal service. The value of the prizes does not exceed the value set by law, for which the organizer should pay an advance income tax.

Article 5

Winners are not entitled to claim a different prize or prizes in larger quantities than those specified in these rules. The prize cannot be exchanged for cash or transferred to another person. The organizer does not take any responsibility concerning the utilization and use of prizes.

Article 6

The commission consisting of: Simona Jeraj and Gregor Švetak is responsible for the implementation and supervision of the lucky prize draw.

Article 7

The organizer of the prize contest is obliged to protect the acquired personal data in accordance with the Personal Data Protection Act and in accordance with the applicable GDPR regulation, and will not

pass it on to third parties in contravention of the law. Participant in the prize contest agrees that the organizer may use the contact information obtained in this prize game (name, surname, e-mail address) for the future purpose of carrying out its promotional activities only in relation to the participant, namely to send e-news about updates on Tadej Pogačar website and its store. The participant also agrees that the organizer has the right to publish the names of the winners on the website <https://tadej-pogacar.com> and the Instagram profile of Tadej Pogačar. The organizer commits itself to stop such notifications immediately when the request is expressed by the participant in any shape or form.
